ENTRY INFORMATION

FACH ENTRY MUST INCLUDE

- An appropriately detailed submission addressing the relevant criteria - the quality and content of the submission will assist in the judging of your entry
- Signed Authority Forms General (includes Builder and Owners permission for the project to be entered into the Awards, used in the media and approval to enter the property) and Photographer
- An A3 floor plan, elevation plan and other relevant drawings/ documentation pertaining to the project plans
- Maximum of 12 high resolution quality digital images supplied as a jpeg (300 dpi minimum for awards magazine and audio visual)
- Uploaded digital images for each entry should have a relevant file name
- Display Home entries need a copy of the promotional material used to promote the home to the public
- Development Approval

HINTS AND TIPS

- Supply as much information needed to ensure your submission addresses the outlined judging criteria.
- Incomplete entries or entries not meeting specified category criteria may need to be re-submitted
- It is compulsory for a client representative to attend the judging appointment as builder/ client relationship is considered an integral part of the judging process
- The builders representative attending the judging appointment must have expert knowledge of the project entered. This will ensure that the judges are correctly informed of the merits of the project as well as any answers to questions they may have regarding the project

JUDGING TIMES will be scheduled with you in advance, but once times are set, cannot be altered. There are a large number of projects to judge and judges can only visit a particular area once. Please ensure there is no issue with access to the project on the designated day. Should there be a period of time that is not suitable for inspection (i.e. no access due to client on holidays) please advise no later than 5.00pm 1st March or risk entry being forfeited

CONDITIONS OF ENTRY

- All projects entered except the Work Health & Safety category must have achieved practical completion between 31 August 2024 and 31 January 2026.
- Entrants must be appropriately licensed in the category entered and a financial member of Master Builders Tasmania
- In order to qualify for an Award, all outstanding membership fees must be paid in full. No awards will be issued to non-financial members
- All entries must be based on 'price on completion' GST inclusive. Display homes must be accompanied by the current list of all inclusions of the home to full specification as displayed construction costs exclusive of furniture, furnishings and landscaping. Contract homes must be based on the value paid by the client on completion Submissions must highlight any works not done by the builder.
- Price per square metre, on completion and category value are all GST inclusive
- All entries must be located in Tasmania
- No more than four entries are allowed per sub-category
- Each entry must be completed in full providing all required details
- Master Builders Tasmania reserves the right to refuse any entry

- The entrant must obtain the owners permission and cooperation when submitting the entry and access for judging. If the building is unoccupied upon entering the competition but later becomes occupied, permission and agreement for access must be obtained by the builder from the occupier to allow judging. In the instance of not being able to obtain access, the entry will be automatically disqualified and all associated fees forfeited
- All documents and photographs remain the property of Master Builders Tasmania and may be used for promotional purposes
- Entries, fees and photos must be lodged online on or before
 5.00pm Sunday 1st March 2026 -LATE OR INCOMPLETE ENTRIES
 WILL NOT BE ACCEPTED
- Refunds will not be made if any entry is withdrawn or cancelled after the closing date
- Master Builders Tasmania and its media partners accept no responsibility for any incorrect details, spelling or other incorrect information stated in the entry
- The judges reserve the right to decide if an entry has been entered into the incorrect category and transfer it accordingly

CONDITIONS OF ENTRY

- The judges reserve the right to decline to present an award in a particular category if a minimum standard of excellence has not been achieved
- Judges must have internal access to the building at the agreed upon time
- The judges or Master Builders
 Tasmania will not enter into any
 correspondence regarding
 judging
- Supplementary hard copy information provided at your judging appointment may not be taken into account by the judges. If you have important information pertaining to the project, it should be provided as part of your original submission. Judges also advise entrants against sitdown presentations at judging appointments
- The entrant/ award recipient
 must agree to state the category
 type or recognition received and
 the year awarded whenever
 disclosing information or
 promoting itself or the entry in
 any communications or media

*Projects must have been completed and Certificate of Occupancy (or relevant completion certificate) obtained between 31 August 2024 - 31 January 2026 inclusive.

 In the event that a home has been built without a contract (e.g. a builder constructing their own home) the entrant must seek special permission from Master Builders Tasmania to enter. The home must be entered into the category that best represents the market value of the cost of the build. Evidence must be supplied, including a copy of the Home Warranty Insurance Certificate, to support this category selection. Master Builders Tasmania reserves the right to reject an entry or move between categories.
